## **Notification of Manufactured/Imported Chemicals**

Manufacturer, importer or seller, who deals with new chemicals or existing chemicals ( $\geq 1$  ton/yr), has to annually notify, report and save the result of its use and amount to the Ministry of Environment.

 Chemical inventory and the reporting on behalf of manufacturer(s) /importer(s).

## **Joint Submission**

New chemicals or existing chemicals ( $\geq 1 \text{ ton/yr}$ ) have to be registered before manufacture · import. When submitting required forms for the same substance, you need to decide the representative and co-register.

However, if it includes confidential information or takes more costs for co-registration, then you can submit individually with verification of Ministry of Environment.

- GHS/MSDS preparation with local regulation.
- Implementation testing strategy and GLP testing agency.
- Data sharing and CBI protection legal advisory.

When each hazardous chemical within the article exceed 1 ton/yr, you need to notify, report and save the result of chemical name, content and hazard information before manufacture or import.

 Chemical inventory and the notification on behalf of manufacturer(s) /importer(s).

## **Chemical Information Sharing within Supply Chain**

The person who transfers registered chemical or a mixture has to provide registration number, chemical name, hazard and risk information, safety usage information, etc to the person who receives it.

When manufacturer or importer asks for chemical usage, exposure information, usage or sales amount, safety usage information, etc, the downstream user or seller has to provide these information(vice versa).

When consumer asks for the chemical name, usage, conditions, etc that contains in the article, the person who transfers this article has to provide these information.


